This information sheet is provided to assist you to process your citation. **Please note: A telephone call does not constitute an appearance.** You have the following options available:

1. You may enter a plea of guilty or nolo contendere (no contest) and pay your fine. There is a plea form on bottom of back page for you to fill out and send in with payment of fine.
2. You may enter a plea of not guilty and you will be set on the court docket and notified by mail of your court date and time. This plea must be in writing and sent to the court at address above.
3. If you qualify you may request a driver's safety course. The request form is located on the back side of this form and you must call the court before sending information to the court.

If you are unable to pay your citation there are alternative ways to take care of it. These alternatives can be explained to you at the court or by you calling the court at the number listed above.

Plea and request for DSC filled out and notarized

Copies of valid Texas Driver's license and current insurance card that lists your name as a driver.

There is a \$144.00 fee that must be paid to the court for DSC if you are eligible for DSC and complete all requirements in the specified time this will be the only money you pay to the court
